Change Order #2 covers two changes to the project. First, Haas proposed to substitute a different material for the limestone screenings. Second, the chiller lines between the HVAC equipment and the library are quite shallow and conflict with the proposed retaining wall. Ayres has proposed Change Order #2 affecting these changes in the contract. The net cost increase for Change Order #2 is +\$5,445. City Staff recommends approval of Change Order #2.
